2026 Fees Policies

Payment terms & non-payment policy

1. Fees are payable **in advance**, monthly or termly.
2. Fees are invoiced upfront.
3. Accounts not settled by the **3rd of the month** will be considered overdue.
4. Interest of **12% per month** may be charged on overdue balances.
5. Learners with outstanding fees may be denied access to academic services and platforms until the account is brought up to date.
6. MPower Learning Centre reserves the right to suspend or terminate enrolment if fees remain unpaid for **one full calendar month**.
7. All legal costs incurred in the recovery of outstanding fees will be for the account of the parent/guardian.

Termination of Enrolment

Termination by Parent/Guardian

- **One calendar month's written notice** is required.
- Failure to provide notice will result in fees being payable in lieu of notice.

Termination by MPower Learning Centre

MPower Learning Centre reserves the right to terminate enrolment with immediate effect if:

- Fees remain unpaid after one calendar month
- The learner's needs cannot reasonably be accommodated within the academic model
- Continued enrolment is deemed not to be in the best interest of the learner or the school community

No refunds will be issued in such circumstances.
